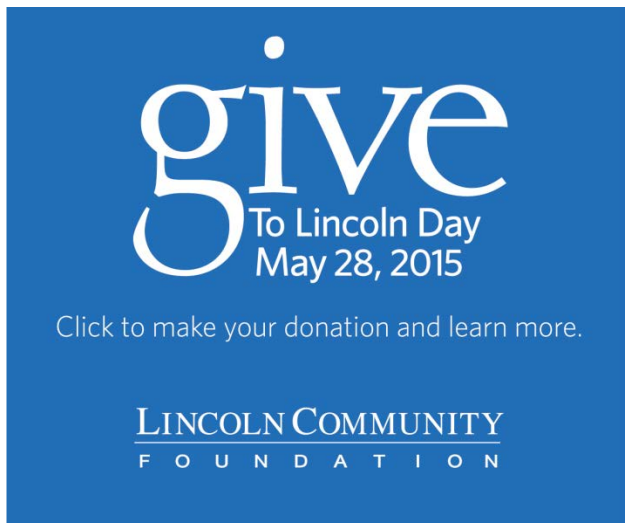

Give to Lincoln Day

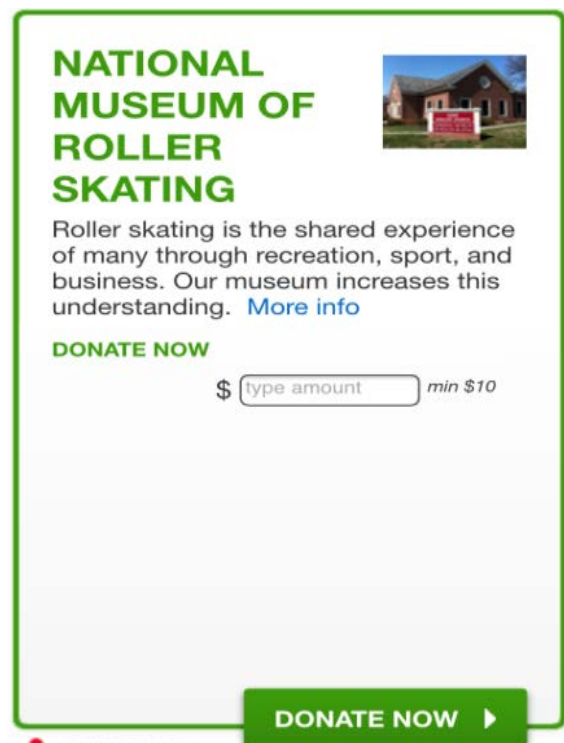


The museum will again participate this year in "Give to Lincoln Day". On May 28 for a 24 hour period, anyone in the country can donate to a participating Lincoln non-profit organization. These funds go directly to the non-profit as a fundraiser effort.

Sponsored by the Lincoln Community Foundation (LCF), over 330 different organizations will participate in this citywide event, gaining attention for all of the great charity work done throughout the community.

As with last year the LCF has pledged a \$300,000 match to be distributed on percentage basis to every participating organization. The larger the amount raised the greater amount LCF will match to that organization. Last year our museum received a 12% match from LCF.

Last year our museum supporters stepped up and made donations to our organization under this fundraising event. We had a total of twenty-two different donors give to the museum. With the final tallies announced, the museum received \$4,310 in donations. We hope to have similar success this year.

RSA Convention 2015



Each year the museum participates in the annual Roller Skating Association Convention and Trade Show. Here we host our annual Museum Board of Trustees meeting, showcase a booth at the trade show, and hold our annual museum raffle fundraiser.

Trade Show



At the annual Roller Skating Association trade show the museum produces a booth every year to keep our mission in the minds of the closest to the sport. We show old footage, display antique skates, sell raffle tickets, push for membership, and answer questions or concerns about the museum.

This year we brought five antique skates to display and received many compliments and questions. These skates included an 1880s Fenton cast-iron skate, a 1930s Best-Ever-Built inline, an 1880s Henley wooden skate, a 1930s Winston quad street skate, and a child's cowboy boot skate from the early 2000s. The cowboy boot skate received the most comments as the theme of the convention was "Rodeo Roundup."

It is always great to speak with rink owners and skate providers about the museum. Many help promote the museum by posting a link to our website on their homepage, including museum fliers in their programs for competitions, or simply following us on social media and sharing information.

We appreciate the RSA allowing us to exhibit at their annual convention and trade show.

Museum Raffle

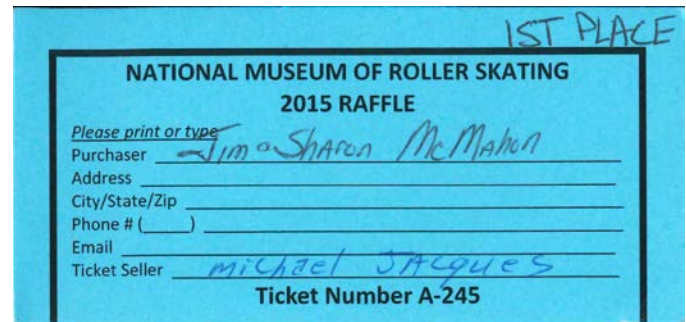
The museum had another successful raffle this year at the RSA Convention. Throughout the convention museum trustees and supporters did a great job selling tickets to their fellow RSA members.

Ticket selling finished at the end of the reception prior to the RSA President's Dinner. Museum members then collected all tickets and calculated totals and prize money.

The museum sold 242 total raffle tickets for a total of \$12,100. Half of this money went directly to the museum while the other half was awarded as prize money for the three raffle tickets chosen.

As if purchasing these raffle tickets in the first place were not support enough, each of the three winners donated back part of their winnings to further help the museum.

Dominic Cangelosi donated \$210 of his winnings.
Brian Gamsby donated \$305 of his winnings.
Jim & Sharon McMahon donated \$2,115 of the winnings.

This is an additional \$2,630 that goes straight to the museum. Adding this with the \$6,050 raised from our half of the proceeds, the museum raised in total for the 2015 raffle **\$8,680**.

We want to express our gratitude for all of those diligent folks helping us sell raffle tickets. You are all to be commended. And thanks to the RSA for allowing us to hold our raffle at your annual convention.

And finally, thanks to everyone who purchased raffle tickets this year; so many of you help support our raffle every single year. Your support is vital to our museum.

King of Color: The Story of Derby Star Wes Aronson

From the Aug 1941 issue of *Roller Rage*



It was during a recent game at the Roller Derby that the announcer's voice cut into the general din with the announcement one Wes Aronson, who had been off the track for a time due to injuries, returned to competition.

Instantly, from some ten thousand throats, came a converted roar of appreciation. Seldom, if ever, had such a display of enthusiasm been displayed at any Roller Derby. For to those fans, as with millions of other Derby fans throughout the country, Wes Aronson symbolizes the Roller Derby at its best.

Considered the most colorful, if not the most capable skater on the track today, Aronson is, with one or two others, the best known of all Derby stars. His name, as though possessing magical qualities, carries news whenever mentioned. One of the very few remaining "veteran" skaters who started out with the Roller Derby in its inaugural meet in 1935, he has built his skating into one of the most brilliant careers known to roller skating.

Wes joined that first Roller Derby with the idea that he was "pretty good". Those old timers who were participating in that race soon knocked that idea out of him...after one or two nights of skating he learned that to get anywhere in this "babe of sport" you had to knuckle down and really skate as you had never skated before. It's that idea that quickly sent him to front ranks among Derby athletes-he never stops giving his best!

Now twenty five years old Aronson is at top form. He is six feet tall, has blonde hair, blue eyes, weighs 165 pounds. An especial favorite with the feminine fans, he has been dubbed the "blonde Adonis" by sports writers because of his striking good looks.

Wes was off the track for several months recently because of injuries received in competition. On his return he quickly and efficiently regained his former place as topnotch skater in his unit. Now again things are as usual-with Aronson skating his way to national fame in city after city, from coast to coast.

Rink Sticker Collection

The museum has an extensive collection of roller skating rink stickers. Many skating rinks used to produce stickers as both an advertisement and fun way to for skaters to interact with one another, comparing the different location in which they skated. These were even traded as collectibles both informally and formally, under the Universal Roller Skating Sticker Exchange founded in 1948. Each newsletter, we will feature different rink stickers.
